BRIEF DESCRIPTION

Title: [Archivalia on constitutional law, land law and land tenure in West Africa]

Origin: Gerti Hesseling

Abstract: The collection contains research data on land law, land tenure and land reforms in Senegal; (newspaper) articles and clippings on Senegal, its political development, parties and press; student theses, legal texts (mainly land law and constitutional law) and miscellanea. The collection covers the period. 1960-1999 with a focus on the 1980s and 1990s.

Biography or History:

Gerti Hesseling (1946-2009) was a Dutch legal scholar specialized in constitutional and land law in West Africa. She joined the African-Studies Centre in Leiden in 1979 to do post-doctoral research on land law and land reform in South Senegal, a project for which she did fieldwork in Senegal. After her return from the field, and the demise of the African Studies Centre's 'Section on Law', Hesseling joined the Department of Political and Historical Studies. She combined the writing-up of her Senegal data with research on a topic that had also been central in her doctoral dissertation: the study of human rights as enshrined in the national constitutions of African independent states. Gradually, her interest shifted from Senegal to the whole of West Africa, and from legal scholarship to development and senior management. She also supervised the fieldwork of Leiden anthropology students in Senegal. From 1996 to 2004, Hesseling was the Director of the African Studies Centre in Leiden. From 2006 until her death in March 2009, she was a research professor in human rights and peace building studies at Utrecht University.
