Biopolitics, militarism, and development: Eritrea in the twenty-first century / ed. by David O'Kane & Tricia Redeker Hepner - New York: Berghahn Books, 2009.

Abstract: Once hailed as "the African nation that works" Eritrea's apparently succesful post-independence development has since lapsed into economic crisis and severe human rights violations. This is due not only to the border war with Ethiopia that began in 1998 but also the result of explicit policies of social mobilization first adopted by the Eritrean government during the liberation stuggle (1961-1991) and later carried into the post-independence era. Placing the Eritrean case in a broader transnational and global context, this collective volume exposes the multiple consequences of these policies for the Eritrean people and the ways in which such policies are resisted or subverted. Snapshots of student-teachers' experiences of DVDs in a learner support programme in a developing ODL context / Illasha Kok and A. Seugnet Blignaut. - In: *Africa Education Review:* (2014), vol. 11, no. 4, p. 526-543: graf

Abstract: The School of Continuing Teacher Education (SCTE) in South Africa delivers an Advanced Certificate in Education (ACE) Learner Support Programme to Open Distance Learning (ODL) students in Namibia, a developing sub-Saharan African country. This paper examines the experiences of student-teachers using DVDs included in the tutorial package. Fifteen participants from rural and remote areas of Namibia took part in a semi-structured focus group and individual interviews. A first phase analysis identified a set of codes and categories that guided the researchers to two themes to using DVDs: frustration and attitude. Student-teachers' frustration and attitude towards DVDs are linked to sufficient appropriate information, also available as a paper-based tutorial package. Although electronic learning material can assist in achieving curriculum goals and enrich students' learning experiences, students' expectations are paramount in the design and development of instructional DVDs. Access constraints experienced by physically disabled students at a South African higher education institution / L. Engelbrecht and J. J. de Beer. - In: *Africa Education Review:* (2014), vol. 11. no. 4. p. 544-562

Abstract: Current developments in government law and policies have created the hope that people living with a disability will enjoy the same rights and privileges as the non-disabled. Unfortunately, only 2.8% of disabled persons have access to higher education. The aim of this study was to determine if a group of students, living with a physical disability, experienced constraints with regard to access to a South African higher education institution. This study, following a two-phase sequential mixed method approach, consisted of a questionnaire survey, a focus group discussion, and individual interviews. It was found that students living with a physical disability experienced constraints relating to the accessibility of the relevant higher education institution. Since access constraints affect the lives of students living with a disability, it is necessary to provide guidelines to universities on how to address these challenges. Bibliogr., notes, sum. Money and violence : financial self-help groups in a South African township / by Erik Bähre -Leiden; Boston: Brill, 2007.

Abstract: This ethnography is about the way in which Xhosa migrants in the townships of Cape Town, South Africa, collectively manage their money in financial self-help groups, also known as financial mutuals. This is an umbrella term for a myriad of collective financial arrangements that are mostly informal. In South Africa they are known locally as 'umgalelo', stokyel, sayings. gooi-gooi, throw-throw, back-to-school, 'umasingcwabane', 'umasiphekisane' and 'umasingcedane' and include burial societies, rotating savings and credit associations (ROSCA), and accumulating savings and credit associations (ASCRA). Financial mutuals are islands of hope for Xhosa migrants surrounded by insecurity, unemployment, murder, rape and social conflict. Migrants have de-politicized their financial mutuals and created a place where they can feel secure and trusted and where money is in their control. Particularly women have created these de-politicized social spaces. Based on fieldwork in Indawo Yoxolo, the author explores the nexus of money and social interdependencies within an extremely threatening context, discussing anxiety among members of financial mutuals, the fragility of solidarity and trust, as well as the emergence of conflicts with kin, household members, and neighbours, over desperately needed money, and its consumption.
